# A Family Reunited!

**A**s the Madison community ushered in the year 2015, a young family was reunited. Three years ago a young professional won the green card lottery and was given the opportunity to immigrate to the United States. He arrived, adjusted to a new climate and a new culture, found employment and a new community. He worked hard, picking up overtime when possible and exhausting himself physically at a job for which he was overqualified. This gentleman saved as much money as he could but also sent some back to his home country, where his family waited.

His wife, an educated young woman with three small children, worked patiently as she plodded through the visa process to gain access to the US. Several months ago, the family had a chance to see each other briefly in a nearby country, in order to move the immigration process along. What followed was another long wait, with this young father setting money aside to purchase plane tickets for his wife and children.

Finally, as the ball dropped at twelve o'clock on New Year's Day, this lovely family was able to embrace each other once more.

This was just the start of their journey, together, in the United States. Looking for guidance, the family reached out to Jewish Social Services and was quickly connected with our Individual and Family Services social worker. Katy Polich, MSW helped assess their needs, and then aided them in the process of getting settled. She provided advocacy and assistance with locating appropriate affordable housing, determining which community benefits the family was eligible for, accessing clothing and supplies for the children, finding necessary medical care, and connecting with the Madison Metropolitan School District. Jewish Social Services helped the family arrange their move to their new home in March. This young couple reports much gratitude for the opportunities that have been offered to them. Jewish Social Services will continue to be part of their support system, as they continue to enrich our community.

## JSS welcomes Elena Robbins as Administrative Manager

**I**n January of 2015 Elena Robbins eagerly stepped into her new role as the Administrative Manager for Jewish Social Services. She came to JSS seeking a career that would be beneficial to the local community. Raised in the suburbs of Chicago, her family placed the principle of helping others as a high priority. Participating in outreach programs with the Epilepsy Foundation and closely aiding her mother in offering services to children with autism, Elena found herself interested in a nonprofit sector career. Reflecting on her upbringing, she states, “My parents naturally incorporated the idea of tikkun olam (repairing the world) into our childhood, right next to eating vegetables and going to school.” In 2011, she graduated from the University of Illinois at Chicago with a Bachelor’s degree in Political Science and International Relations. During her time at UIC she also worked in the College of Liberal Arts and Sciences on campus, assisting her fellow students while honing her administrative skills.

Elena then moved to Madison to complete the Professional French

Masters Program with an emphasis on International Development and Nonprofit Management. While pursuing her degree, she completed an internship with a women’s health organization (RENATA) in Yaoundé, Cameroon, aiding heavily stigmatized minority groups in the West African country. It was truly an edifying experience, allowing her to gain perspective on life in a foreign country, as well as the inner-workings of a nonprofit organization.

Over the past few months, Elena has enjoyed finding her place at JSS and getting to know her co-workers. Some of her projects include sending out the monthly electronic newsletter, creating flyers, aiding in data management and event registration, and designing the new Haggadah used at the senior Passover seders. As someone with a background in international relations, Elena has found aiding JSS Immigration Services with their frequent workshops particularly interesting. She has felt an overwhelming sense of community among all those involved with JSS and hopes to remain a part of the organization for a very long time.

# Planning for Transition Home after Hospitalization or Rehab

**S**pending time in the hospital or in a rehab facility can be stressful, but with proper planning and support, your transition home can be made much easier.

In order to ensure a smooth transition, it is necessary to begin thinking about it as early as possible. Identifying key people to assist in the plan is important. In general, the facility social worker is in charge of assisting patients with coordinating care needs. You may request a care conference so that you, your family and/or other support persons, hospital/rehab case manager and medical staff can review your progress and anticipate what your needs will be at time of discharge. If you have had a long rehab stay, having another meeting close to your discharge date is important. Come prepared with a list of questions and take notes. It is helpful to have a family member/caregiver present to take notes as it may be difficult to absorb everything that is being discussed.


Make sure you understand any changes to your medications and potential side effects. Ask to have needed prescriptions sent to the pharmacy before you leave. If you will need home health care such as OT or PT, the physician will need to write an order for that. Be sure you understand any new precautions or care you may need to follow.

People often confuse home health and home care services. Home health is a Medicare-covered benefit and is provided for a limited period of time as long as you need skilled home health such as PT/OT/RN. A shower aide may be provided for as long as you are receiving skilled services. You must be home bound while receiving home health.

Home care is considered an unskilled service and is NOT covered by Medicare. Unless you have long term care insurance, you pay out-of-pocket. Home care services may include assisting with personal cares such as dressing, bathing, and toileting. It may also include housekeeping, shopping and meal preparation, depending upon

your needs. If you will need home health or home care services those arrangements should ideally be made prior to discharge.

It is important to plan ahead for any needed adaptations in your home or any equipment, such as a hospital bed, a walker or wheelchair, or a shower stool and grab bars in the bathroom. Remove items that may cause falls, such as area rugs and cords, and reduce excess clutter to allow for easy passage from room to room.



You may need to ask someone to shop for groceries and fill your prescriptions so these will be ready upon your return.

Keep any follow-up doctor's appointments. Call your doctor ASAP if you experience any symptoms/warning signs once you return home.

The JSS Senior Services Specialist is available to help you with these transitions. If needed, we may attend care plan meetings and help advocate for the patient. We can help guide you through the process of choosing a home care agency, obtaining equipment/home adaptations and connect you with other resources. Once you return home we can check in to see if your needs are being met.

Good planning, preparation and follow up are the keys to avoiding re-hospitalization.

## INTERNATIONAL CORNER



### Living in America – Perspective of an Immigration Services Client

*This article was written by a client of our Immigration Services program. While she was eager to share her story, we have respectfully left out her name in order to grant her request for anonymity.*

**M**y family and I came from Mexico to the U.S. when I was about four years old. We came because we were living in extreme poverty. Even though my father worked sunrise to sunset we could not get ahead. We lived in a small one room house with dirt floors. The house was falling apart, and we had no heat or air conditioning. We were also fleeing from all the violence that was taking place. There was always the fear that you would get mugged, kidnapped, or killed.

When we arrived here we moved in with family in Minnesota. I faced numerous challenges adapting to the many changes I experienced in the U.S. Our first obstacle was the language. I was able to quickly pick up English, but my parents could not. At the young age of five, I became my parents' translator. As a result, I matured more quickly than other kids my age. I was dealing with adults and "adult things" on a regular basis; however, I do not regret this. Being bilingual opened more doors for me than I ever imagined possible. Another obstacle we had to overcome was the weather. We were used to the warm weather in Mexico. However, we quickly adapted to the freezing cold weather in Minnesota out of necessity. Growing up, I was also faced with the reality of racism. I realized at a young age that people are discriminated against because of the way they look. The experience that I recall the most happened at the hospital. In my opinion a hospital has the obligation to help anyone regardless of race, gender, or sexual preference. Unfortunately, that was not the case when my mom needed to go in for a cardiac test. The doctor there refused to perform the test on my mother because of the color of her skin. Many people witnessed this event, but not one person stood up for us. We had no choice but to wait hours for a different doctor to perform the test. Unfortunately for us, racism is still a very real part of our lives. One day I will hopefully be able to say that we have overcome this obstacle too.

Thanks to Deferred Action for Childhood Arrivals (DACA) I am able to drive, work, and travel inside the U.S. Even though

this permit is not a path to citizenship, it has given me freedom that I did not have before. For example DACA has allowed me to obtain my license at the same time the rest of my classmates have, and I can now travel with my friends to see the beautiful sights of this country. My dream is to eventually travel all over the world. I would also like to participate in international humanitarian work. Unfortunately, for right now those dreams are put on hold. I am hoping for immigration reform in the near future. This would not only allow me to fulfill my dreams, it would also allow my family to stay together. Ever since I was a little girl I have lived with the fear that my parents would be taken away from me at any second. Sometimes I would stay up all night to make sure nothing bad happened. However, going to school was what I dreaded the most. I always feared that my parents were going to be taken away when I was at school. No one should have to live with the fear that I did and still do. My parents will be eligible to apply for Deferred Action for Parental Accountability (DAPA) because my two younger siblings were born in the United States. With DAPA there is hope for my family staying together. My siblings and I will be able to live without the fear of never seeing our parents again. Also my parents will be able to work, drive, and travel inside the United States.

I am very thankful to Jewish Social Services for all their help. Janice was extremely helpful, caring, and professional throughout the whole process. She was there for me every step of the way, and was always there to answer my questions. In addition she checked up on me after her job was done. My family was able to afford professional help from Jewish Social Services because of their low fees. They also go out of their way to get information out to as many people as they can. They recently held an educational session on DAPA. Both my parents and I attended. They presented a lot of useful information, and they had many people to whom we could talk to if we had questions. Jewish Social Services is the place to go if you want a professional and caring environment.

### Charlie Shoham, "Why Not?"

One way or another, Charlie Shoham has been helping people all his life. When he was a child, his older brother was injured in a terrible automobile accident; the therapies that helped his brother recover left a strong impression on Charlie. As a result, Charlie chose to become a rehabilitation physician, developing skills and attitudes that proved important when he became a caregiver for his late wife, Sue Ann. When he himself became disabled later in life, he found that volunteering provided a way for him to continue to help people. He uses this professional expertise and personal experience while serving on the Access to Independence Board of Directors.

Charlie is a cheerful man, down-to-earth and open-hearted. His tendency is to see that there's a way to do something rather than to lament that it's difficult or impossible. In the four years that Charlie has been volunteering for Jewish Social Services, many JSS volunteers have benefited from this attitude. Charlie has also developed long-lasting relationships with those he helps. On a weekly basis for the past four years, he visits with an elderly man with dementia and patiently listens to his stories and questions.

This has provided some much-needed respite for the man's wife and enriched both of their lives.

Charlie has also been a Friendly Visitor for a couple of years for a middle-aged woman with disabilities who feels isolated, rarely leaving her apartment. He visits her twice weekly for two hours at a time.

The woman is very social and loves to converse, so she and Charlie are a very good match and seem to share endless topics of interest. She wrote us a note saying, "I just wanted to say thank you for introducing me to Charlie. I am really enjoying getting to know him. We have much in common in both work and health experiences."

She says there are few people who can really understand what it is like to be as disabled as she is, but Charlie does.

Since last summer Charlie has been volunteering with an elderly, highly educated and accomplished woman from another country who speaks almost no English. What started as an English-language session evolved into a way to breach language barriers and start a friendship. Recently he took on a second woman from the same country because, as he says, "Why not, if I can be helpful, and I really enjoy getting to know these people."

We at Jewish Social Services are so grateful that Charlie Shoham and so many others like him enjoy giving their time and energy to help our clients. And, as he says, it's a lot of fun for him too.
